Jefferson County Fair Camping Rules & Regulations

1. **IF THIS FORM IS NOT COMPLETELY FILLED OUT & FEES PAID IT WILL BE RETURNED**
2. All Trailer/Tents must have campsite permit posted where visible. Park the camping unit on the **X** marked in the grass & in between the lines designated. One camping unit and one vehicle allowed per site. All other vehicles must be parked in the designated parking lot. Any extra vehicles will be towed at owner's expense. Tents beside camping units are intended for small tents. Sewer hook up is not guaranteed.
3. Dogs or pets not involved in the fair must be kept contained at the campsite at all times, except service animals. **NO EXCEPTIONS.**
4. Lanes between parked camping units must remain open at all times for emergency access and fire protection. **ABSOLUTELY NO AUTOS IN THE FIRE LANES.**
5. Use or possession of intoxicants, narcotics, illegal drugs, or use of vulgarity is prohibited on the grounds, and camping area. Any campers using loud or profane language will be dismissed from the Fair. General Rules of the Fair Apply.
6. Clubs and family members wishing to be together must state so at the time of registration. There will be no rearranging of spaces once they are assigned. There must be an adult staying in each campsite.
